### LICENSE AGREEMENT 許可合約

### 1. SCOPE OF THE LICENSE AGREEMENT 許可合約範圍

- 1.1 MACA grants the Applicant a license agreement to perform in public musical works within MACA's repertoire in the circumstances and by the methods herein described.
  在 MACA 的曲目範圍內及根據本許可合約所述的條件,MACA 授予申請人在公開場合播放或演出的許可證明。
  - Within the scope of MACA's repertoire and in accordance with the conditions described herein, MACA grants the Applicant a license to perform musical works in public within a specific range on a regular basis, in the form of background music, and regardless of any medium or hardware.
  - 在 MACA 的曲目範圍內及根據本許可合約所述的條件,MACA 允許申請人在特定範圍內的公開場合恒常性、以背景音樂的方式且不論以任何媒介或硬件播放或現場演出有關音樂作品。
- 1.2 The license agreement granted in Clause 1.1 does not include: 本許可合約内的第 1.1 項條款不包括:
- (a) Public broadcasts or live performances other than those mentioned in the license agreement;本許可合約所述場所以外地方的公開播放或現場演出:
- (b) One-off event, new media and third party owned business should be licensed separately and directly by MACA; 短期活動、新媒體及第三方營運的業務場所皆須獨立向 MACA 申請版權許可;
- (c) Broadcasts or live performances of any musical work with new or adapted lyrics that are not within the scope of MACA's repertoire or any lyrics which have been notified by MACA as prohibited; or

- (d) Any rights not expressly granted in this license agreement. 未在本許可合約中明確規定的任何其他權利。

- 2. DURATION OF THE LICENSE AGREEMENT 許可合約之期限
- 2.1 Unless otherwise specified, Applicants are allowed to broadcast or perform musical works for 12 months from

- 2.2 After the license agreement period has expired, if neither party proposes to terminate this license agreement, the license agreement will be renewed for the same period in the subsequent year, and MACA will also issue a corresponding invoice to the Applicant and Applicant have to complete the payment as described in Clause 6 of this license agreement.

- 3. LICENSED AREA 許可範圍
- 3.1 Places where musical works can be broadcasted or performed are subject to the invoice and license certificate issued by MACA.

- 4. CALCULATION OF LICENSE FEE 許可費用計算詳情
- 4.1 MACA will evaluate the amount due by the Applicant based on the information declared by the Applicant in the application form and according to the license fee that has been determined for the year.

- 4.2 The determined license fee is the calculation based on standard tariff provided by MACA for the type of venue to be applied for and the Applicant has read and understood the calculation method and amount. 定出許可費用的標準為根據 MACA 提供的適用於擬所申請的場所類型的許可標準收費表所定出的計算標準,而申請人已閱讀並明白有關計管方式及全額
- 4.3 The annual license fee payable by the Applicant is the total amount listed on the relevant invoice issued by MACA. 申請人應繳付的年度許可費用為 MACA 於有關發票上所列出的總額。
- 4.4 If the actual data collected by MACA is not consistent with the information declared by the Applicant, MACA has the right to adjust the relevant amount payable according to the actual collected data, and has the right to issue invoice and collect from the Applicant the difference between the relevant amounts.

- 4.5 MACA reserves the rights for final decision regarding the calculation and the amount of the license fee. MACA 保留有關許可費用的計算方式和金額的最終決定權。
- 4.6 If the Applicant fails to settle the fee stated in this license agreement after reminder from MACA; and legal proceedings occurred as a result, the Applicant still needs to pay to MACA the outstanding license fee as well as the administrative, legal and other costs incurred in recovering the license fees.

### 5. SUPPLY OF INFORMATION 資料提供

- 5.1 If any change in the content of the application form, the Applicant has to inform MACA in written notice of the details within 14 days from the change.

- 5.2 On request by MACA, the Applicant must provide a report of the musical works used in the Properties/Area within the time limit specified by MACA in a table format including original performers, authors, composers, publishers, etc.

#### 6. PAYMENT OF LICENSE FEES 繳付許可費

- 6.1 The Applicant has to settle the amount payable calculated in accordance with Clause 4 within 30 days from the date of MACA's invoice.

- 6.2 In any such proceedings where a notice of invoice stating the permit fees calculated and payable in accordance with the terms of the permit agreement has been sent out to the Applicant, such notice or Invoice shall be evidence that the sum therein mentioned is the sum that Applicant is liable to pay MACA.

- 7. TERMINATION OF THE LICENSE AGREEMENT 許可合約終止
- 7.1 MACA has the right to give the Applicant a notice of immediate termination of the license agreement and will not refund the license fee. The Applicant should pay the administrative, legal and other costs that may result from it, if the Applicant:

- 8. DEFINITIONS 定義
  - In this license agreement: 在本許可合約中:
  - A license refers to a permit, this permit allows the Applicant to broadcast or perform the relevant musical works on a regular basis, in the form of background music, and in any media or hardware, within the scope of the musical works of MACA's repertoire and under the conditions described herein, in public places within a specific range.

  - License Year Is the 12-month specified period on the Invoice in accordance with Clause 2 of this LICENSE AGREEMENT.

  - **Licensed Area** refers to the broadcast or performance of musical works within MACA's repertoire in the premises specified on the invoice.

  - Works within MACA's repertoire refers to all musical works managed by MACA in Macau, including (but not limited tol musical works managed by Collective Management Organizations that have signed reciproctal agreements with MACA and registered in Macao Economic and Technological Development Bureau, and the musical works in the song query system provided on the official website of MACA http://www.maca.org.mo/

  - Invoice refers to the payment notice issued by MACA in response to the Applicant's consent to the application to enter into the license agreement.

  - **ONE-OFF** Event refers to public live performances, such as concerts, musical performances, exhibitions, art shows, carnivals, or shopping mall events, during a specific period and in a specific premise.

New Media refers to a web or mobile platform originating in or available In Macau.

### 9. NOT ASSIGNMENT 不可轉讓

This LICENSE AGREEMENT is for individual Applicant. Without MACA's written consent, the Applicant must not assign, transfer, sub-license or other means to transfer all or part of the rights in this LICENSE AGREEMENT. 本許可合約是面向申請者個體的,如沒有 MACA 的書面同意,該申請人不得分配、轉讓、次級許可或以其它方式移轉本許可含約之全部或部份權利。

- 10. NOTICES 注意
- 10.1 The notice under this LICENSE AGREEMENT must be given in writing to the Applicant through the following channels:

- 11.1 MACA has the right to pursue any breach of the terms of this LICENSE AGREEMENT or any breach of terms stipulated in this LICENSE AGREEMENT. MACA also has the right to recover from the Applicant the outstanding license fees, the losses suffered by MACA due to the Applicant's failure to perform other terms of this LICENSE AGREEMENT, the administrative, legal, and other costs incurred in recovering the license fees.

In addition, this LICENSE AGREEMENT can only be amended upon written consent by both parties.
