1. SCOPE OF THE LICENSE AGREEMENT 許可合約範圍

- 2. DURATION OF THE LICENSE AGREEMENT 許可合約之期限
- 2.1 Unless otherwise specified, Applicants are allowed to broadcast or perform musical works for 12 months from the date listed on the Invoice.

- 2.2 After the license agreement period has expired, if neither party proposes to terminate this license agreement, the license agreement will be renewed for the same period in the subsequent year, and MACA will also issue a corresponding invoice to the Applicant and Applicant have to complete the payment as described in Clause 6 of this license agreement

- 4.1 MACA will evaluate the amount due by the Applicant based on the information declared by the Applicant in the application form and according to the license fee that has been determined for the year MACA 會根據申請人於申請表所聲明的資料,按照已釐定適用於該年度的收費表来評估申請人應付的款項。
