LICENSE AGREEMENT 牌照合約

1. SCOPE OF LICENSE 牌照範圍

1.1 MACA grants the Applicant a license to perform publicly or authorize the public performance of any on all musical works within MACAs repertoire in the circumstances and by the methods herein described.
在MACA的曲目範圍內及根據本文所述的條件, MACA授予申請人在公開場合播放或演出的許可證。

1.2 The license in clause 1.1 does not include or authorize 在第1.1項條款不包括或授權:

- (a) the public reception of any performance beyond the precincts of the Premises; 牌照所述場所以外地方的公開播放或演出;
- (b) One-off event, new media and third party owned business should be licensed separately. 短期活動、新媒體及第三方營運的業務普須獨立申請牌照。
- (c) the performance of any musical work with new or substituted lyrics, or any lyrics which have been notified by MACA as prohibited; or

(d) any other right not expressly granted under this agreement.

2. DURATION OF THE AGREEMENT 合約年期

Unless otherwise specified, this agreement is for an initial period of 12 months for the period described in the Invoice. Either party will need to send the other party a written notice at least 1 month in advance to terminate the initial period.

3. LICENSE AREA 授權區域

4. CALCULATION OF AMOUNT PAYABLE 版權費計算細節

- 4.1 Subject to MACA's right to reassess the amount payable under clause 4.2, the Applicant must pay MACA an amount equal to the total sum stated in the invoice for the first License Year.

- 4.2 On MACA's receipt of the information, MACA may issue an invoice for the increased/decreased amounts payable.

5. SUPPLY OF INFORMATION 資料提供

5.1 The Applicant must send MACA a written notice within 14 days of any change to the particulars in the application form.

7. TERMINATION 合約終止

MACA may immediately terminate this agreement by notice to the Applicant if the Applicant: MACA有權向申請人發出立即終止合約的通知,如果申請人:

- (a) fails to pay any sum when due under this agreement within 30 days after the due date; 未能在協定30天內繳納牌費;
- (b) breaches any other term of this agreement and fails to remedy the breach within 7 days after being requested in writing to do so by MACA;

(c) being a corporation, goes into liquidation, has a receiver or receiver and manager appointed to it or any part of its assets, enters into a scheme of arrangement with creditors or suffers any other form of external administration; or

8. DEFINITIONS 定義

License Year means any 12-month period as specified in the Invoice in accordance with Clause 2.

Licensed Area means the Premises named in the Invoice where Works within MACA's repertoire performed under this license are audible.

Works within MACA's repertoire means all musical works, including any words normally associated with those works, the rights of public performance of which is owned or controlled by MACA for Macau.

MACA的曲目範圍是指在澳門,MACA所管理的所有音樂作品,其中包括與這些作品相關的任何文字。

9. NOTICES 注意
