





作曲家、作家及出版社協會(MACA)是澳門目前唯一正在執行澳門著作權 法賦予之權利的非牟利非政府集體管理組織。在國際作者和作曲者協會聯合會 (CISAC)的支持下,合法於澳門特區政府身份證明局和經濟及科技發展局知識產 權廳登記成立。旨在保護本地及海外會員的音樂作品的公開播放權。

Macau Association of Composers, Authors & Publishers is the sole operating and registered collective management organization (CMO) currently in Macau. With the support of the International Confederation of Societies of Authors and Composers (CISAC), registered in the Macau Department of Identification and the Intellectual Property Department of Economic and Technological Development Bureau. MACA's aim is to protect the public performing right of local and overseas members' musical works.

在著作權方面,MACA 在澳門著作權制度之根基下,管理及執行本地及海外聯會作曲家及作詞家的作品權益,現時本會管理超過二百萬名來自澳門本地會員以及 49 個海外聯會會員之音樂作品,當中包括 117 個本地作曲家、作詞家及音樂出版社。根據作品於澳門的使用率,所有版權費用經扣除行政費用後將會全數分配予本會會員及海外聯會,並由海外聯會分配予其會員。同樣地,透過與海外聯會簽署的互惠協議,在世界多個國家及地區,根據當地版權法於當地保護MACA 會員作品的權益。

Regarding the copyright, MACA administers and enforces collectively the rights of composers and authors of musical works subsisting under the copyright law of Macau. MACA at present controls the copyright of musical works created by over two million local members and members from 49 affiliated societies, including 117 local composers, authors and publishers. All royalties, after the deduction of its administrative costs, will be distributed to local members and overseas affiliated societies according to the usage rate of the works in Macau. Reciprocally, to protect and administer the rights of MACA's members in more countries and territories outside of Macau by means of reciprocal agreements with overseas societies.

在社會文化活動方面,MACA 積極推動版權意識,加強公眾對音樂創作人的尊重,確保他們的原創作品得到適當的報酬。此外,MACA 亦推廣及支持音樂活動,鼓勵本地創作及設立音樂教育基金,以提高澳門的音樂創作水準。

Regarding the social and cultural activities, MACA raise the public awareness on copyright issues, reinforce the public's respect towards composers and authors and ensure that their creative efforts are properly remunerated. Also, to promote and support musical activities, encourage local composition and award music scholarship to improve local standard of music creation.



大家好! 2023 年可謂是九轉功成的一年。澳門特別行政區政府宣佈自 2023 年 1 月 8 日結束疫情過渡期後,各項通關政策陸續恢復。各種大中小型演唱會、音樂會、粉絲見面會等演藝活動及其他文娱活動如雨後春筍般在澳門綻放,隨之澳門政府亦宣佈致力建設澳門成為"演藝之都"。

Hello, everyone! 2023 could be described as a year of successful transformations. The Macao Special Administrative Region Government announced that since the end of the epidemic transition period on January 8, 2023, various immigration policies have gradually resumed. A variety of large, medium, and small—scale concerts, music events, fan meetings, and other entertainment activities have blossomed in Macao. Following this trend, the Macao government also announced its commitment to building Macao into the "City of Performing Arts".

隨著澳門各行各業經濟的恢復以及各項利好政策的推行,作曲家、作家及出版社協會MACA(以下簡稱"協會")的音樂版權許可事務和分配工作亦得到逐步提升。協會經本地會員或其他國家/地區已簽署互惠協議的授權,替其會員在澳門向音樂使用者發出音樂公開使用版權許可並收取許可費用,而該筆費用會根據音樂使用報告,由專業電腦系統進行大數據統計後得出分配結果,相應金額由本協會分配給澳門本地會員以及由已與本協會簽署互惠協議之國家或地區的音樂版權集體管理機構分配予其會員。歷經三年的疫情,陰霾終於過去,相信隨著未來有更多文藝活動及體育盛事在澳門舉行,將有利於澳門音樂創作和音樂版權事業往更好的前景發展。

With the recovery of Macao's economy across various industries and the implementation of various favourable policies, the music copyright licensing and distribution work of Macau Association of Composers, Authors and Publishers (hereinafter referred to as the "MACA") has also been gradually enhanced. Through authorization from local members or reciprocal agreements signed with other countries/regions, MACA issues music public performance licenses to music users in Macao on behalf of its members and collects licensing fees. These fees are then distributed based on music usage reports, which are processed by a professional computer system for big data analysis.

The corresponding amounts are then allocated by MACA to local members in Macao and to members of music copyright collective management organizations from other countries or regions that have signed reciprocal agreements with MACA. After three years of the epidemic, the clouds have finally passed. I believe that with more cultural and sports events being promoted in Macao in the future, it will be conducive to the further development of Macao's music creation and music copyright industry towards a brighter future.

在對外拜訪交流工作方面,本年度協會代表拜訪了中國國家版權局版權管理局、中央人民政府駐澳門特別行政區聯絡辦公室、澳門經濟及科技發展局、澳門海關、澳門法務局、澳門文化局、澳門旅遊局、橫琴粵澳深度合作區民生事務局等政府部門。協會十分感謝中國國家版權局版權管理局及澳門政府部門長期以來對推動知識產權和音樂版權發展以及對協會工作的支持!同時在中國國家版權局版權管理局的支持和指導下,開展了由中國音樂著作權協會(MCSC)和香港作曲家及作詞家協會(CASH)與本會聯合舉辦的「粵港澳大灣區音樂作品著作權集體管理高峰論壇」,並積極參與中國國際版權博覽會暨國際版權論壇、知識產權研討會等活動,深化澳門與中國內地和香港三地知識產權的交流合作。

In terms of external visits, MACA representatives have visited various government departments, including the National Copyright Administration of China, the Liaison Office of the Central People's Government in the Macao Special Administrative Region, the Macao Economic and Technological Development Bureau, the Macao Customs Service, the Macao Legal Affairs Bureau, the Macao Cultural Affairs Bureau, the Macao Government Tourism Office, the Livelihood Affairs Bureau of Guangdong-Macao In-Depth Cooperation Zone in Hengqin and other government departments. We are deeply grateful to the National Copyright Administration of China and the Macao government departments for their long-term support in promoting intellectual property and music copyright development, as well as for their support of MACA's work! With the support and guidance of the National Copyright Administration of China, we have launched the "Guangdong-Hong Kong-Macao Greater Bay Area Collective Management of Copyright in Musical Works Forum," jointly organized by the Music Copyright Society of China (MCSC) and the Composers and Authors Society of Hong Kong Ltd (CASH) and MACA. We have also actively participated in events such as the China International Copyright Expo and International Copyright Forum, Intellectual Property Seminars and other events to strengthen exchanges and cooperation among mainland China, Hong Kong, and Macao, deepening cooperation on intellectual property among the three regions.

在活動宣傳推廣方面,協會透過舉辦「版權知多 D 嘉年華」、「MACA 音樂獎學金頒獎典禮」、「走進錄音室工作坊」、「全澳校園版權知識巡禮」等年度大型活動,從而培育更多優秀音樂創作人才以及提高公眾版權意識。在國際事務方面,協會作為國際作者和作曲者協會聯合會(CISAC)的其中一員,堅持積極參與 CISAC 亞太區委員會會議及各項音樂版權管理培訓,向 CISAC 及海外聯會彙報協會工作的近況並學習最新的版權管理模式。

In terms of event promotion, MACA organizes annual events such as the "MACA Copyright Funfair", "MACA Music Scholarship Awards Ceremony", "MACA Studio Workshop" and the "Macao Copyright Campus Tour" to cultivate more outstanding music creators and raise public awareness of copyright. Internationally, as a member of the International Confederation of Societies of Authors and Composers (CISAC), MACA actively participates in CISAC Asia—Pacific Committee meetings and various music copyright management training sessions. We report on the recent developments of MACA's work to CISAC and overseas associations and learn about the updated copyright management models.







全澳校園版權知識巡禮 Macao Copyright Campus Tour

2023年1月起 From January 2023

從 2023 年 1 月,作曲家、作家及出版社協會(MACA)繼續進入校園開展全澳校園版權知識巡禮,希望能夠透過活動,由學校入手,從學生教育開始,培養下一代,潛移默化,深入淺出,把版權知識滲透至新生代,從而加深本澳居民對侵權行為的認識。從 2017 年起至今,該活動已在本澳的 45 間中學及 4 間大學中開展了 103 場次,活動正在持續進行中。

Since January 2023, Macau Association of Composers, Authors & Publishers (MACA) continue going to campus for the event "Macau Copyright Campus Tour". Hoping the start from the school and student education through activities, infiltrating and in-depth cultivating copyright knowledge into the new generation, deepening the understanding of Macau citizens on copyright infringement. Since 2017, this activity has been carried out 103 times in 45 middle schools and 4 universities in Macau, and the activity will be running continuously.

MACA strives to provide its members and more citizens a better understanding of the intellectual property right and music copyright, in order to encourage the public to respect music and protect copyright. Since May 2018, provided there are no special circumstance, MACA Open day is set up every month to allow the public to learn more about music copyright face to face and also clear all their doubts regarding music copyright. From January to December 2023, MACA hosted 12 Open Days, and this event will be running continuously in the future.



CISAC Asia Pacific Committee (APC) Meeting

2023年5月及12月 May and December 2023

由國際作者和作曲者協會聯合會(CISAC)主辦的亞太區委員會會議分別於 5 月及 12 月在泰國 曼谷及印度齋浦爾進行。

The CISAC Asia Pacific Committee Meetings were held in May and December in Bangkok and Jaipur.

會議上有來自中國內地(MCSC)、日本(JAS-RAC)、台灣(MÜST)、韓國(KOMCA,KOSCAP)、菲律賓(FILSCAP)、新加坡(COMPASS)、泰國(MCT)、香港(CASH)、澳門(MACA)、澳洲(APRA)、印度(IPRS)、印尼(WAMI)、越南(VCPMC)、馬來西亞(MACP)、蒙古(MOSCAP)、加拿大(SOCAN)、美國(ASCAP,BMI)、英國(PRS)等18個國家及地區逾70位代表參與,共同探討人工智能對版權管理工作的影響。在提高音樂作品

質量和產量的同時,需要提升音樂作品識別功能及版稅分配系統,從而更快速精準地運作。

More than 70 representatives from 18 territories including Mainland China (MCSC), Japan (JASRAC), Taiwan (MÜST), Korea (KOMCA, KOSCAP), Philippines (FILSCAP), Singapore (COMPASS), Thailand (MCT), Hong Kong (CASH), Macau (MACA), Australia (APRA), India (IPRS), Indonesia (WAMI), Vietnam (VCPMC), Malaysia (MACP), Mongolia (MOSCAP), Canada (SOCAN), USA (ASCAP, BMI), UK (PRS) attended the meeting, focusing on the impact of artificial intelligence on copyright management. While improving the quality and quantity of music works, faster and more accurate identification of music works and the operation of the royalty distribution system are required.
